

WHY ARE RATES INCREASING?



Periodic adjustments to rates are necessary to ensure the continued provision of vital and reliable community services, adjusting for annual increases in utilities, infrastructure, maintenance, and resources to provide water, wastewater, and solid waste services.

HIGHLIGHTS



On average, we deliver 22 million litres of water per day to customers and return 80% to the Wapiti River.

The Eco Centre is the largest recycling depot in the region, recycling items such as paint, electronics, used motor oil, Styrofoam and household hazardous waste.
