The aforesigned hereby applies for water and wastewater services to the premises described on the application and agrees to pay for such services at the times and rates prescribed in the applicable utility bylaw for the service area:

- The City of Grande Prairie Utility Bylaw C-1139
- The County of Grande Prairie No. 1 Utility Bylaw No. 3070
- The Town of Sexsmith Utility Bylaw No. 848 D

These bylaws regulate and provide the terms, conditions, rates and charges for the supply and use of the water, wastewater and solid waste utilities provided by Aquatera Utilities Inc.

The aforesaid further agrees to pay Aquatera's infrastructure and meter charges at the rates applicable pursuant to Aquatera's Infrastructure Charge Policy on the date of payment. A schedule indicating current rates under the Infrastructure Charge Policy can be found at [www.aquatera.ca](http://www.aquatera.ca) and are subject to revision at any time.

Aquatera Utilities shall have the right to disconnect, interrupt or reduce utility services at any time without notice, for any of the following reasons:

- a) For making repairs or improvements necessary to facilitate construction, installation, maintenance, repair, replacement or inspection of any part of the utility services;
- b) To restrict and regulate the use of water for the purpose of conserving water;
- c) To maintain the safety and reliability of the utility services;
- d) Due to any other reason, including non-payment of rates and /or charges, emergencies, forced outages, force majeure or potential shortage or interference with the normal delivery of the utility service

#### **ANY CONSUMER**

- a) Whose water supply is not metered or
- b) Whose meter is not positioned to the satisfaction of the Manager, shall, at the Consumer's expense, arrange for the installation of a new meter or for the meter to be moved, as the case may be.

#### **PROTECTION OF METER**

A consumer shall adequately protect the meter on the Consumer's property against freezing, heat and any other internal or external damage failing which such Consumer shall pay Aquatera the cost of repairing or replacing the meter.

**Payment of Aquatera Infrastructure and Meter Charges is due and payable prior to turn on of water services and installation of a water meter.
