This notice explains changes in monthly charges for your water, wastewater and solid waste services. Rate changes are **effective July 1, 2021** and will be reflected on your August utility bill.

WHY ARE RATES INCREASING?



Periodic rate increases are required to ensure the delivery of essential services, adjusting for annual increases in utilities, maintenance and resources to provide water and wastewater services.

Upgrades to river infrastructure will ensure a reliable water supply by providing flood and erosion protection and improving emergency response and resiliency.



\$35 million in capital investments planned.

Upgrades to our treatment facility will provide increased capacity for the next 30 years as the region grows.



FAQ'S



Solid waste charges (garbage collection and recycling) on your monthly bill are collected on behalf of the County of Grande Prairie No. 1, who provides this service.

On average, we deliver 20 million in litres of water per day to customers.



We return 80% of the water back to the Wapiti River.

We maintain \$325 million worth of assets throughout the service area.
